



## Petroleum Business Tax Rates For Commercial Vessels

This publication lists the petroleum business tax rates for use of non-highway diesel motor fuel by commercial vessels.

Tugboat, towboat, and other commercial vessel operators using the working-days method to compute the petroleum business tax must use the following rates:

Motor fuel	\$0.169 per gallon
Diesel motor fuel	\$0.1515 per gallon

If you operate a commercial vessel that is not a tugboat or towboat, you may not use the tax-per-trip method. You must use the working-days method.

Tugboat and towboat operators using the tax-per-trip method (Schedule A of Form PT-350, *Petroleum Business Tax Return for Fuel Consumption – Commercial Vessels*) must use the following rates:
