**Rate per gallon explanation chart**

- .0005 - includes the rate for petroleum testing fee only
- .0665 - includes the rates for petroleum business tax at the retail sellers of aviation gasoline rate (.066) and petroleum testing fee (.0005)
- .0805 - includes the rates for motor fuel excise tax (.08) and petroleum testing fee (.0005)
- .1665 - includes the rates for petroleum business tax (.166) and petroleum testing fee (.0005)
- .2465 - includes the rates for motor fuel excise tax (.08), petroleum business tax (.166), and petroleum testing fee (.0005)
