Please read instructions below before completing this schedule.

If you are a registered distributor engaged in the sale or commercial use of liquors containing more than 24% alcohol by volume in New York City, or in the sale of liquor containing more than 24% alcohol by volume to a purchaser whose licensed premises are in New York City, complete this schedule and attach it to Form MT-40, *Return of Tax on Wines, Liquors, Alcohol, and Distilled or Rectified Spirits*.

If you are a noncommercial importer, do **not** complete this schedule. Instead, enter on Form MT-40, line 18, the number of liters of liquors containing more than 24% alcohol by volume that you brought or caused to be brought into New York City.

You must keep records to support all entries on this schedule.

Instructions

Amounts must be reported in whole liters.

All purchases or sales may be reported as a one-item total from each source.

Liquors include distilled or rectified spirits, alcohol, brandy, cordials (whether the base is wine or liquor), whiskey, rum, gin, and all other distilled beverages containing alcohol, including all dilutions and mixtures of one or more of the foregoing, and also any alcoholic liquors that would be wines if the alcoholic content were not more than 24% by volume.

Line 2 — Enter the total of all purchases of these alcoholic beverages that include New York City alcoholic beverages tax. **Details of purchases must be shown on the back of this schedule.**

Line 3 — Enter the total of all sales of these alcoholic beverages made outside of New York City. This includes out-of-state sales and New York State tax-paid and tax-free sales within New York State but outside New York City.

Details of sales must be shown on the back of this schedule. Do not include sales to purchasers whose licensed premises are in New York City.

Line 4 — Enter the total of all sales of these alcoholic beverages made in New York City on which New York City alcoholic beverages tax was not paid. **Details of sales must be shown on the back of this schedule.**

Line 5 — Enter loss and waste from Form MT-40, line 7. You must explain this deduction on a separate sheet and attach it. It is subject to approval by the Tax Department.

Attach this completed schedule to Form MT-40, Return of Tax on Wines, Liquors, Alcohol, and Distilled or Rectified Spirits. Attach additional sheets if necessary.

Line 7 — Subtract line 6 from line 1. Enter the result in the liters column on Form MT-40, line 18.
