## Instructions

## Who must file this application

Individuals who import more than 90 liters of liquors but not more than 360 liters of liquors into New York State or New York City during a one-year period for the individual's personal use and consumption must have a license before importing the liquors.
Individuals importing 90 liters or less may apply for a temporary license.

Persons intending to import liquors for sale, or to import more than 360 liters during any one-year period for personal use and consumption, must register as a distributor of liquors using Form TP-215, Application for Registration as a Distributor of Alcoholic Beverages.

Any person transporting more than 90 liters of liquors must be registered as a distributor or have a temporary license.

## When to submit this application

You may apply for a license no more than 30 days before the time that you intend to import the liquors.

## Other documentation that must be submitted

Proof of ID - Proof of identification (picture ID with signature and proof of age) must be available.

Section 420 of the Tax Law defines liquors as any distilled or rectified spirits, alcohol, brandy, cordial (whether the base therefor be wine or liquor), whiskey, rum, gin, and all other distilled beverages containing alcohol, including all dilutions and mixtures of one or more of the foregoing. Also, any wines if the alcoholic content thereof is more than $24 \%$ alcohol by volume.
