# Home Heating System Credit and the Clean Heating Fuel Credit

On May 21, 2006, Governor Pataki signed into law Chapter 35 of the Laws of 2006. The new legislation, in part, provides for two new tax credits: the home heating system credit and the clean heating fuel credit. A discussion of the new credits follows.

# Home heating system credit

# General

For tax years beginning in 2006 and 2007, an individual can take a credit against his or her New York State personal income tax based on the costs incurred by him or her on or after July 1, 2006, and before July 1, 2007, that are directly associated with the replacement of an existing home heating system. The replacement system must be installed in a residence that is the taxpayer's principal residence at the time the costs are incurred. The residence must be located in New York State and the installation must be completed before December 31, 2007. The credit is not allowed for the installation of a home heating system in a newly constructed principal residence.

To qualify for this credit, the home heating system that replaces the old system must, after installation, qualify for and be labeled with an Energy Star label. An Energy Star label is placed on a home heating system by the manufacturer pursuant to an agreement by the manufacturer with the United States Environmental Protection Agency and the United States Department of Energy.

The amount of the credit is equal to 50 percent of the costs incurred on or after July 1, 2006, and before July 1, 2007, that are directly associated with the replacement of an existing home heating system. However, the credit cannot exceed \$500. If the principal residence is shared by two or more taxpayers, the amount of the credit allowable to each taxpayer is to be prorated according to the percentage of the total costs incurred by each taxpayer.

If a taxpayer moves from one principal residence to another principal residence in the state, and replaces the home heating system in each residence with a heating system that meets the conditions to qualify for this credit, the taxpayer will be allowed a separate credit of up to \$500 for each residence.

The credit is allowed for the tax year (2006 or 2007) in which the installation of the Energy Star labeled replacement system is completed, provided the installation is complete by December 31, 2007. However, the credit is based only on the costs incurred on or after July 1, 2006, and before July 1, 2007.

#### **Definitions**

*Principal residence* means the home where the taxpayer lives most of the time. A summer or vacation home does not qualify. A principal residence can be a house, whether owned or rented, a mobile home, cooperative apartment, or condominium.

Home heating system is the primary system in the home that generates heat and distributes it by air, water, or steam to various rooms of the house. A system that provides heat and also provides hot water for the home for bathing, etc., will also qualify. However, a system that produces only hot water for bathing, etc., will not qualify.

The costs incurred that are directly associated with replacement of an existing home heating system include the amounts paid on or after July 1, 2006, and before July 1, 2007, for the purchase and installation of the replacement system and the removal of the old system. These costs include costs incurred for materials and labor, including materials and labor for the installation of any pumps, pipes, duct work, etc., that are necessary for the proper functioning of the system, and any engineering and design costs. These costs do not include any interest or finance charges. Costs are incurred when the taxpayer is obligated to pay the cost, even if the taxpayer has not actually paid the cost. If the replacement home heating system provides heat for both the taxpayer's principal residence and to nonresidential property associated with the residence, the entire cost qualifies for the credit.

# **Examples**

Example 1: On July 7, 2006, a taxpayer signs a contract to have an Energy Star labeled home heating system installed in the taxpayer's principal residence in New York State to replace the old system at a total cost of \$2,000. The installation of the replacement system is completed on July 20, 2006, and the taxpayer pays the \$2,000. The credit is allowed for this system for tax year 2006. The credit cannot exceed 50% of the costs incurred between July 1, 2006, and July 1, 2007, or \$500, whichever is less. Since 50% of the costs incurred during the period are \$1,000 (\$2,000 X .50), the credit allowed for this home heating system replacement is limited to \$500.

Example 2: On May 14, 2007, a taxpayer signs a contract to have an Energy Star labeled home heating system installed in the taxpayer's principal residence in New York State to replace the old system at a total cost of \$3,000. Pursuant to the contract, the taxpayer paid the contractor a deposit of \$750 on May 14, 2007. The contract requires the balance due of \$2,250 to be paid upon installation. If the taxpayer cancels the contract prior to installation, the taxpayer is not obligated to pay the balance of \$2,250. The installation of the replacement system is completed on August 3, 2007.

Since the installation of the system was completed in 2007, the credit is allowed for tax year 2007. The credit is based on the \$750 the contract required the taxpayer to pay on May 14, 2007. Since the taxpayer was not obligated to pay the balance due (\$2,250) until the installation of the system on August 3, 2007, the \$2,250 does not qualify as a cost incurred on or after July 1, 2006, and before July 1, 2007. The credit cannot exceed 50% of the costs incurred between July 1, 2006, and July 1, 2007, (\$750) or \$500, whichever is less. Because 50% of the costs incurred during this period are \$375 (\$750 X .50), the credit allowed for this home heating system replacement is limited to \$375.

Example 3: A taxpayer's principal residence in New York State is an apartment on the second floor of a building that has retail space on the ground floor. The primary heating system in the building supplies heat to both the taxpayer's apartment and the retail space. On June 15, 2007, the taxpayer signs a contract to have an Energy Star labeled heating system installed in the building to replace the old system at a total cost of \$4,000. The contract requires the taxpayer to make full payment of the \$4,000 upon signing the contract. The installation of the replacement system is completed on August 3, 2007.

Since, the installation of the system was completed in 2007, the credit is allowed for tax year 2007. The credit is based on the \$4,000 payment on June 15, 2007, since the contract required the taxpayer to make the payment upon signing the contract. The credit cannot exceed 50% of the costs incurred between July 1, 2006, and July 1, 2007, or \$500, whichever is less. Because 50% of the costs incurred during this period are \$2,000 (\$4,000 X .50), the credit allowed for this home heating system replacement is limited to \$500.

#### How to claim this credit

Personal income tax taxpayers claim this credit by filing Form IT-240, *Claim for Home Heating System Credit*, with their New York State personal income tax return. If the amount of the credit allowed exceeds the taxpayer's tax for the year, the excess may be credited or refunded without interest.

# Clean heating fuel credit

For tax years beginning in 2006 and 2007, a New York State personal income tax credit and Article 9-A corporation franchise tax credit is allowed for bioheat that is used for space heating or hot water production for residential purposes within New York State. The credit applies to bioheat purchased on or after July 1, 2006, and before July 1, 2007.

# Who is eligible

This credit may be claimed by:

- Resident and nonresident individuals, estates, and trusts who are taxable under Article 22 of the Tax Law (the Personal Income Tax). This includes an individual, estate, or trust that is a partner in a partnership (including a member of an LLC that is treated as a partnership for federal income tax purposes), a shareholder of a New York S corporation, or a beneficiary of an estate or trust.
- Corporations that are taxable under Article 9-A of the Tax Law (the Franchise Tax on Business Corporations), including a corporation that is a partner in a partnership (or a member of an LLC that is treated as a partnership for federal income tax purposes).

# **Definitions**

For purposes of this credit:

*Bioheat* means a fuel comprised of biodiesel blended with conventional home heating oil, which meets the specifications of the American Society of Testing and Materials (ASTM) designation D 396 or D 975.

*Biodiesel* means a fuel comprised exclusively of mono-alkyl esters of long chain fatty acids derived from vegetable oils or animal fats, designated B100 (pure biodiesel), which meets the specifications of ASTM designation D 6751.

Residential purposes means any use of a structure, or part of a structure, as a place of abode maintained by or for a person, whether or not owned by such person, on other than a temporary or transient basis. This includes multi-family dwelling units such as multi-family homes, apartment buildings, condominiums, and cooperative apartments. Residential purposes do not include the part of a structure used as a hotel, motel, or similar space, except for those units used by the same occupant for at least 90 consecutive days. The structure must be located in New York State.

# **Amount of credit**

The credit amount equals \$0.01 per gallon for each percent of biodiesel included in the bioheat, not to exceed \$0.20 per gallon, purchased by the taxpayer on or after July 1, 2006, but before July 1, 2007. The bioheat must be used for space heating or hot water production for residential purposes within New York State. If a taxpayer makes more than one purchase of bioheat that qualifies for this credit and the percentage of biodiesel included in the bioheat varies, a separate calculation must be made for each purchase of bioheat. If two or more taxpayers share in the purchase of bioheat, the amount of the credit allowable to each taxpayer is to be prorated according to the percentage of the total bioheat purchased by each taxpayer.

The credit is claimed for the tax year (2006 or 2007) in which the bioheat is purchased. In general, bioheat is deemed purchased on the date of delivery regardless of when the payment is made. For example, bioheat that is paid for through a budget payment plan whereby the taxpayer makes monthly payments to the supplier and the supplier charges the taxpayer's account for the cost of the bioheat delivered, will be deemed purchased on the date the delivery was made, even if the taxpayer's budget account does not contain sufficient funds to cover the cost of the delivery. However, bioheat that is purchased under a plan that requires the taxpayer to prepay the supplier for a certain number of gallons of bioheat at a fixed price will be treated as purchased on the date the prepayment was made, not the date of delivery.

In order to properly compute the amount of credit allowed, the taxpayer should have an invoice or bill that includes the following:

- date of purchase (see above),
- number of gallons of bioheat purchased, and
- the percentage of biodiesel included in the bioheat. (Note: The percentage of biodiesel included in the bioheat is the number preceded by the letter "B" in the bioheat designation. For example, bioheat designated B5 contains 5% biodiesel, bioheat designated B20 contains 20% biodiesel, etc.)

Example 4: On December 29, 2006, a taxpayer receives a delivery of 100 gallons of bioheat to be used for residential heating purposes within New York State. The invoice requires the taxpayer to pay for the fuel within 30 days of delivery. Each gallon of bioheat contains 30% biodiesel (B30). Since the credit is \$0.01 per gallon for each percentage of biodiesel included in the bioheat, not to exceed \$0.20 per gallon, the amount of credit allowed for this purchase is limited to \$20.00 (\$0.20 X 100 gallons). Since the bioheat was delivered (purchased) in 2006, the credit is claimed on the taxpayer's 2006 income tax return even though the taxpayer may actually pay for the bioheat in 2007.

Example 5: On August 15, 2006, a taxpayer signs a fixed price contract with a heating fuel supplier and prepays for 1,000 gallons of bioheat. Each gallon of bioheat includes 10% biodiesel (B10). The bioheat will be delivered to the taxpayer's home in New York State and will be used for residential heating purposes. Therefore, the taxpayer will be allowed a credit of \$0.10 per gallon (\$0.01 X 10). As of December 31, 2006, the supplier has delivered only 400 gallons of the 1,000 gallons purchased on August 15, 2006. For tax year 2006, the taxpayer is allowed a credit of \$100.00 (\$0.10 X 1,000 gallons) for the entire purchase of bioheat made on August 15, 2006, even though the remaining 600 gallons of prepaid bioheat will be delivered to the taxpayer in tax year 2007.

Example 6: On August 1, 2006, a taxpayer enters into a budget payment plan with a heating fuel supplier for the purchase of bioheat to be used for heating the taxpayer's residence in New York State. The budget plan covers the period from August 1, 2006, to June 30, 2007. The supplier estimates that the taxpayer's fuel cost for this period will be \$ 2,100. The taxpayer agrees to pay \$210 per month to the supplier for the next 10 months, starting on

August 15, 2006, and ending on May 15, 2007. The supplier will deliver bioheat on an as needed basis. There is no set number of gallons to be delivered under the terms of this plan and the supplier has the right to adjust the monthly payment amount due based on the taxpayer's actual use and the market price of the bioheat.

The supplier delivers 230 gallons of bioheat on September 20, 2006, that includes 20% biodiesel (B20). The total cost of the September 20, 2006, delivery of bioheat is \$598 (230 X \$2.60/gallon). On December 18, 2006, the supplier delivers another 190 gallons of B20 bioheat at a cost of \$513 (190 X 2.70/gallon).

As of December 31, 2006, the taxpayer has made five payments of \$210 (\$1,050) into the budget payment plan and the supplier has made two deliveries of bioheat (September 20, 2006, and December 18, 2006). The supplier has charged \$1,111 against the taxpayer's account for the two deliveries. The taxpayer's account now indicates a negative balance of \$61.

For tax year 2006, the taxpayer is allowed a credit based on the 420 gallons of bioheat that was delivered (purchased) under the budget payment plan in tax year 2006, even though the taxpayer had a negative balance in his budget account after the charge for the deliveries. The amount of credit allowed for the purchase of bioheat in tax year 2006 is \$84 (\$0.20 X 420 gallons).

On February 6, 2007, the supplier delivers 200 gallons of B20 bioheat at a cost of \$540 (200  $\times$  \$2.70/gallon) and on April 4, 2007, the supplier delivers another 130 gallons of B20 bioheat at a cost of \$338 (130  $\times$  \$2.60/gallon). There are no other deliveries of bioheat on or before June 30, 2007, which is the end date of the budget payment plan.

Between January 1, 2007, and May 15, 2007, the taxpayer has made five payments of \$210 (\$1,050) into the budget payment plan and the supplier has charged \$878 against the taxpayer's account for the deliveries made on February 6, 2007, and April 4, 2007, and \$61 for the negative balance as of December 31, 2006. Accordingly, on June 30, 2007, the taxpayer's account indicates a positive balance of \$111 which will remain in the taxpayer's account for the next heating season.

For tax year 2007, the taxpayer will be allowed a credit based on the 330 gallons of bioheat that was delivered (purchased) in tax year 2007 (after December 31, 2006, and before July 1, 2007). The amount of credit allowed for the purchase of bioheat in tax year 2007 is \$66 (\$0.20 X 330 gallons).

If a taxpayer purchases bioheat for a premises that has both residential and nonresidential space but has only one tank for the storage of the bioheat fuel, the taxpayer will need to use the following formula to determine the percentage of the premises used for residential purposes in order to properly compute the credit.

# For purposes of the formula:

Hotels, motels, etc., may claim as residential square footage only those units used by the same occupant for at least 90 consecutive days.

*Common areas* mean any area on the premises used without distinction for both residential and nonresidential purposes.

Square footage of residential areas

(excluding common areas)

Total square footage of premises
(excluding common areas)

% used for residential purposes (rounded to four decimal places)

The percentage is then multiplied by the number of gallons of bioheat purchased to determine the number of gallons eligible for the credit, as the following example illustrates:

Example 7: Taxpayer X owns a building that has apartments, a restaurant, and retail stores on the premises. The building has one storage tank that is used to store heating fuel for the entire building. X purchases 500 gallons of bioheat on October 12, 2006. Each gallon of bioheat contains 5% biodiesel (B5).

Using the formula above, X determines that the percentage of the premises used for residential purposes is 65%. Therefore, 325 gallons (500 X .65) of the bioheat purchased on October 12, 2006, will be eligible for the clean heating fuel credit. Accordingly, the amount of credit allowed for this purchase for tax tear 2006 will be \$16.25 (\$0.05 X 325 gallons).

# How to claim this credit

Personal income tax taxpayers claim this credit by filing Form IT-241, *Claim for Clean Heating Fuel Credit*, with their New York State personal income tax return. If the amount of the credit allowed exceeds the taxpayer's tax for the year, the excess may be credited or refunded without interest.

Article 9-A corporate franchise tax taxpayers claim this credit by filing Form CT-241, *Claim for Clean Heating Fuel Credit*, and attaching it to their franchise tax return. The amount of the credit deducted for the tax year cannot reduce the tax to an amount less than the tax due on the minimum taxable income base or the fixed dollar minimum, whichever is higher. Any amount of credit not deductible in the current tax year may be credited or refunded without interest.

(Tax Law sections 210(39) and 606(mm))
