Please be sure to sign-in at all sessions that you attend for continuing education (CE) credits. CE credits will also be used to determine your eligible expenses for reimbursement.

*In addition, overnight expenses are available to those eligible who travel over 50 miles from their official stations to the conference.

The maximum amount of overnights that will be reimbursable for this Conference is 3 nights.

****Only a maximum of 12 Continuing Education Credits will be reimbursed*****

Vouchers must be received by ORPTS within 30 days of the conference. Reimbursement rates for Cayuga County Hotel = \$98 per night (must have itemized receipt). Mileage = \$.625 per mile and tolls. Rates are subject to change. Reimbursement will be provided from the Second Training Period (August 1 – November 30). Reimbursement for continuing education may be prorated. Rules allow ORPTS to reimburse a percentage of the expenses when funds are insufficient to cover all expenses.
