6 - 9	One half receipted tuition amount \$87.50	1 overnight, meals, mileage, tolls
3	No tuition	No overnights. Only allow travel meals, mileage, tolls

\*In addition, Sunday overnight expenses are available to those eligible who travel over 50 miles from their official stations to the conference.

Vouchers must be received by ORPTS within 30 days of the conference. Reimbursement rates for Niagara County Hotel = \$96 per night (must have itemized receipt); Meals = \$11 for breakfast and \$45 for dinner (lunch is not reimbursable). Mileage = \$.56 per mile and tolls. Rates are subject to change. Reimbursement will be provided from the Second Training Period (August 1 – November 30). Reimbursement for continuing education may be prorated. Rules allow ORPTS to reimburse a percentage of the expenses when funds are insufficient to cover all expenses.
