Local Sales and Use Tax Rates on Commercial Fuel Cell Systems Equipment, Electricity, and Hydrogen

Effective March 1, 2025

Effective June 1, 2016, the Tax Law provides certain sales and use tax exemptions related to commercial fuel cell electricity generating systems equipment. The exemptions apply to receipts from retail sales, installation, and maintenance of fuel cell electricity generating systems equipment, and qualifying sales of nonresidential electricity and hydrogen generated by such equipment. Qualifying sales are exempt from the 4% state and the 3% Metropolitan Commuter Transportation District (MCTD) sales and use taxes. Sales are exempt from local sales and use taxes only if the jurisdiction imposing the tax elects to provide this exemption. Part 1 lists the local sales and use tax rates that apply to sales of commercial fuel cell systems equipment, and installation and maintenance services to such equipment.

Part 2 lists the local sales and use tax rates for qualifying sales of nonresidential electricity and hydrogen generated by commercial fuel cell systems equipment.

This publication will be updated when local rate changes occur or when jurisdictions enact or repeal an exemption.
