

## Qualified Empire Zone Enterprise (QEZE) Sales and Use Tax Refund Rates

Effective March 1, 2015

### Part 1 – Businesses certified by Empire State Development (ESD) before April 1, 2009

Businesses certified by ESD before April 1, 2009, may apply for a refund of the New York State and MCTD (if applicable) sales and use tax, and in some cases, local sales and use tax, on qualifying purchases. You may apply for a refund **only** if you have applied for and received Form DTF-81, *Qualified Empire Zone Enterprise Sales Tax Certification*, from the Tax Department. You must also receive your *Empire*

*Zone Retention Certificate* from ESD before applying for a refund, and meet all of the other eligibility requirements. A refund claim may be filed only once each sales tax quarter. The chart below lists the tax refund rates currently in effect for businesses certified by ESD prior to April 1, 2009.

The cities of Corning and Hornell (in Steuben County) repealed their local sales and use tax effective March 1, 2015. See Locality Notices ST-15-1 and ST-15-2 for more information.

## Part 2 – Businesses certified by (ESD) on or after April 1, 2009

A business certified by ESD on or after April 1, 2009, may apply for a refund or credit of New York State and, if applicable, MCTD sales and use tax on qualifying purchases **only** if the locality where the purchase is made elects to provide this refund. If a locality is not listed below, it has not enacted this refund and **no** refund of any New York State, MCTD, or local tax is allowed.

You must receive your *Empire Zone Retention Certificate* from ESD before applying for a refund. A refund claim may be filed only once each sales tax quarter.
