TOTAL CE CREDITS	REGISTRATION FEE	OTHER REIMBURSEMENT*
12 Credits	Full receipted tuition amount \$175.00	2 overnights, meals, mileage, tolls
6 – 9 Credits	One half receipted tuition amount \$87.50	1 overnight, meals, mileage, tolls
3 Credits	No tuition	No overnights. Only allow travel meals, mileage, tolls

*In addition, Tuesday overnight expenses are available to those eligible who travel over 50 miles from their official stations to the conference. **Reimbursement rates for Essex County.** Hotel =\$113 per night (must have itemized receipt); Meals =\$12 for breakfast and \$49 for dinner (lunch is not reimbursable). Note that rates are Mileage = \$.56 per mile and tolls. If you have questions about your eligibility for reimbursement, please call (518) 474-1764 prior to attending the conference. Rates are subject to change.

Reimbursement will be provided from the Second Training Period (August 1 – November 30). Vouchers must be received by ORPTS within 30 days of the conference. Reimbursement for continuing education may be prorated. Rules allow ORPTS to reimburse a percentage of the expenses when funds are insufficient to cover all expenses.
